Summer Meeting – DID NOT HAPPEN

- I. Scholarship Award Presented
 - a. 2021 State Tournament The council decided to allow Lake Magnolia to host again
 - b. In April 2020, Johnny Thomas made phone calls to every club and asked if they would be willing to host States Championships under the current pandemic conditions. At that time, everyone said no. At the end of May 2020, things eased up and more sites were willing to have tournaments and skiers were going to tournaments. Lake Magnolia was willing to put on a State tournament at a lesser level and went forward with it. They were not able to do the normal junior activities, junior fundraising, or have a formal banquet. It was decided by the council to allow Lake Magnolia to host States 2021 to allow for the opportunity to properly host the State tournament as it was meant to be hosted.

- c. There is outdoor entertainment (magician and music) already paid for from Junior Development that was cancelled in the past. This can be used for Junior Development or the State Tournament if wanted.
- d. Jeff Gilbert said that Little Mountain had donated money earmarked for Juniors in need which would help pay his/her way toward the next level of tournament such as States, Regionals, or Nationals. This was discussed previously. There was a tournament where all Junior as well as Men 1/Women 1 entry fees were paid for. However, no one has taken advantage of this money otherwise. Also, money that is for the host club can use up to ½ of the money toward entry fees for Juniors.

IV. Treasurer

VII. State Championship Medals

- a. Eddie Carrick -- Proposal is for the association taking over purchasing of state championship medals.
- b. This would take the burden off of the host tournament site.
- c. Would give medals to the top 5 juniors and top 3 adults. (This is the current bylaw)
 - i. Total potential numbers (per Johnny Thomas):
 - 1. boys/girls 1-4 slalom, trick, jump 120 medals
 - 2. men/women 1, mm/mw, om/ow slalom, trick, jump 310 medals
 - ii. \$7.63 per 100

d. 2020 States

- i. Johnny Thomas was in charge of getting medals organized. He ordered from same place used previously.
- ii. He ordered some extra due to the decrease in cost for ordering more. There are some left over for next year.
- iii. Gave Junior Medals total of 31 for \$236.33
- iv. With new proposal, 2020 States would have approximately 94 medals for a total of \$717.22
- e. State already gives \$500 subsidy

VIII. State Championship Drivers/Officials

- a. There are currently 7 senior 3-event drivers; a lot for one tournament
- b. Suggestion is for the association to invite the officials and pay for hotel and their entry if they ski. History has been old school gentleman agreement to invite all senior 3-event officials and drivers
- c. The AWSA Drivers' Committee has the responsibility to ensure that all drivers have the current skills necessary to guarantee skiers the best ride possible. A skier should not have to ski behind a driver who has not practiced his or her skills. Driving skills require continual work during practice and tournaments. The requirements for maintaining a rating are minimal and necessary to ensure our skiers receive the best driving available.
- d. Will leave it up to host site to decide how many and which officials/drivers are invited. Will continue to work get everyone credit for his/her rating.

IX. Call for other New Business

- a. Jack Bond Radios are in the shop
- b. Skyview mentioned possibly putting in a bid for the 2021 Panam tournament. Since it is a "closed" tournament, it will not be in conflict with current tournament bylaws.
- c. Council Members
 - i. Elections were postponed for all positions for 1 year
 - ii. Elections will be held in same fashion at the State Tournament 2021
 - iii. Will discuss going to online voting, hopefully having a proposal by Mid-winter meeting 2021

d. Sure Path

- i. The 2022 IWW group is moving to Sure Path and will be a requirement for all class L & R tournaments. At 38-off or above, each skier will have the opportunity to request a re-ride at the end of each pass
- ii. The Southern Region is proposing Sure Path be used for all class R tournaments; recommended for all class L tournaments. This will be voted on at the January meeting.
- iii. Currently, Skyview and Little Mountain would be the sites affected

- iv. Due to some difficulty with the use of Sure Path, you may continue tournament as long as you have a backup and will not disqualify tournament if Sure Path not working.
- v. Recommend NCWSA representative vote in favor of this proposal
- e. Future Tournament dates
 - i. There may be other sites wanting to get into rotation. As it is now, the month of June is taken up by primary dates. These dates are highly sought after due to weather and timing during the season. May not be fair to other clubs. Suggestion of a rotation of primary dates. Example would be the June primary date clubs would rotate with the September primary date clubs.
 - ii. No official proposal was presented
